IRS DATA RETRIEVAL:

The best way to verify tax information is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web. If you have not already used the tool, then you should go to www.fafsa.gov, go into your FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. From there, follow the instructions to determine if you are eligible to use the IRS Data Retrieval Tool to transfer 2017 IRS income tax information into your FAFSA.

IRS Tax Return Transcript:

To obtain an IRS Tax Return Transcript, go to www.IRS.gov/Individuals/Get-Transcript. Click on "Get Transcript by MAIL".

Make sure to request the "IRS Tax **RETURN** Transcript" and not the "IRS Tax Account Transcript" for tax year 2017. You will need your and your spouse's (if married) Social Security Number, Date of Birth, and the address on file with the IRS (normally this will be the address used when the 2017 IRS Tax Return was filed). If successfully validated, you and your spouse (if married) will receive the Tax Return Transcript with 5–10 business days. Submit all pages (front & back) to us.

IMPORTANT NOTE:

If you are married and you and your spouse filed separate 2017 tax returns, then you will need to submit 2017 Tax Return Transcripts for both you and your spouse.

VERIFICATION OF NON-FILING LETTER FOR INDEPENDENT STUDENTS

To obtain a Verification of Non-filing Letter, print the IRS Form 4506-T from the Financial Aid Forms webpage.

- Complete Lines 1-4, following the instructions on Page 2 of the Form 4506-T.
- Line 5 has been pre-populated with Wilmington College's address so that the Verification of Non-filing Letter will be sent directly to Wilmington College.
- Enter the student ID in Line 5b.
- Check the box on Line 7.
- Sign and date the form and enter the taxpayer's phone number.
- Mail or fax the completed form to the appropriate address/fax number associated with the taxpayer's state of residence.

Wilmington College should receive the Verification of Non-filing Letter within 30 days of the IRS receiving your request.

AMENDED TAX RETURN FILERS

An individual who filed an Amended Income Tax Return (IRS Form 1040X) for tax year 2017 must submit to Wilmington College:

- A 2016 IRS Tax RETURN Transcript, which will reflect information from the originally filed tax return. Be sure to submit all pages (front and back) to us AND
- A signed copy of the 2017 IRS Form 1040X (Amended U.S. Individual Income Tax Return) that was filed with the IRS. Be sure to submit both pages of the tax document to us.

VICTIMS OF IRS IDENTITY THEFT

An individual who was a victim of IRS tax-related identity theft must submit to Wilmington College:

- A Tax Return Database View (TRDBV) Transcript for tax year 2017. This document must be obtained directly from the IRS' Identity Protection Specialized Unit (IPSU) by calling their toll free number 1.800.908.4490. Once the taxpayer's identity has been authenticated, the IRS will mail the taxpayer the TRDBV. Be sure to submit all pages (front and back) to us AND
- A statement signed and dated by the tax filer indicating that he or she was a victim of IRS tax-related identity theft and that the IRS is aware of the tax-related theft.
