2019-2020 ABILITY TO BENEFIT (ATB) VERIFICATION

- I have completed a secondary school education in a homeschool setting that is treated as a homeschool or private school under State law.
 - I was homeschooled in a state where the state law requires a student to obtain a secondary school completion credential for homeschool. An official copy of the credential has been submitted to the Office of Admission.
 - I was homeschooled in a state where the state law does not require a student to obtain a secondary school completion credential for homeschool. A transcript or the equivalent, signed by the parent or guardian, that lists the secondary school courses the student completed AND includes a statement that the student successfully completed a secondary school education in a homeschool setting has been submitted to the Office of Admission.
- I have earned an Associate's Degree at a post-secondary institution.
 - An official FINAL College Transcript reflecting a degree grant date, as well as, an official FINAL High School Transcript with a graduation date has been submitted to the Office of Admission.

Important Note Regarding Transcripts:

Please arrange to have your final Academic Transcript(s) or equivalent, including official graduation date/degree grant date, sent to the Office of Admission as soon as possible, but no later than August 1, 2019.

Consequences:

Failure to submit all final transcripts will result in the loss of financial aid and may prevent you from enrolling at Wilmington College until the student can provide the documentation to satisfy this financial aid eligibility requirement.
