2019-2020 SELECTIVE SERVICE REGISTRATION VERIFICATION

SECTION A: STUDENT INFORMATION

Under the law, all male U.S. citizens, regardless of where they live, and male immigrants, whether documented or undocumented, residing in the United States, who are 18–25 years of age, are required to register with Selective Service within 30 days of their 18th birthday. That means men are required to register with Selective Service sometime during the 30 days before their 18th birthday. Failure to register with Selective Service can result in a hold being placed on your account preventing you from enrolling in classes and from receiving financial aid funds.

- ✓ We cannot continue processing your financial aid until all required financial aid documents have been submitted.
- ✓ All required documents must be returned to our office within two weeks.
- ✓ We will update your FAFSA, if needed, based on the information provided on this form.

SECTION B: SELECTIVE SERVICE REGISTRATION

PLEASE CHECK THE APPROPRIATE BOX AND SUBMIT REQUIRED DOCUMENTATION LISTED BELOW:

- I am registered with Selective Service. Attached is a copy or screen print from the Selective Service website verifying my registration. Register online at www.sss.gov. Click Register, then Register Online. Complete Online Registration Form. Submit Registration.
- I am under the age of 18 years old and am therefore not currently required to register with Selective Service. I understand that 30 days prior to my 18th birthday I must register with Selective Service and submit proof of registration to Wilmington College.
- I was born a female and therefore am not required to register with Selective Service. Attached is a copy of my Birth Certificate.
- I am a veteran who is 26 years of age or older and served on active duty in the armed forces, excluding reserve forces, National Guard, or Delayed Entry pool. Attached is a copy of my DD Form 214 "Certificate of Release of Discharge from Active Duty".
- I was 26 years of age or older when I entered the United States and did not register with Selective Service. Attached is documentation reflecting my date of entry into the United States. Acceptable documentation includes: Date of entry stamp in your passport, I-94 with date of entry stamp on it, or a letter from the U.S. Citizenship and Immigration Services (USCIS) indicating the date you entered the United States.
- I am unable to provide any of the documents requested above. Please attach all items listed below to this form and submit to our office.
1. A Status Information Letter from the Selective Service Office. You can obtain a Status of Information Letter online at www.sss.gov. Click on Registration tab, then Status Information Letter. Click on Status Information Letter Request Form (red box). If you have questions or need assistance call Selective Service directly at 847-688-6888.
 2. A signed written explanation for reason for failure to register.
 3. Supporting documentation to substantiate your explanation.

By signing this form, I certify the information on the form and any attachments are accurate and complete to the best of my knowledge and that there is no forgery of signature(s). The information supplied on this form supersedes that which was provided on the FAFSA. I understand that any false statements or misrepresentation may be cause for denial, reduction, withdrawal, and/or repayment of financial aid, and I may be subject to a fine, imprisonment or both, under provisions of the United States Criminal Code.
